


Presumptive Drug Test Kits



Progressive Systems for Drug Identification, Nark II has the capability of presumptively identifying several families of substances suspected of being abused drugs. Designed to function as a transportable narcotics laboratory, it is available for use wherever the need for its capability might arise. Each of the test is comprised of one or more chemical regents. When a predictable color or series of colors occur within a specific testing sequence, a positive confirmation may be presumed. Presumptive indentification is generally recognized within our legal system as a componet of probable cause. There is no drug identification system presently in use which completely eliminates the occurrence of false positives and false negatives. A forensic

laboratory is required to qualitatively identify an unknown substance.

4990 - This in-Vitro alcohol kit is used for the withdrawl and storage of whole blood. Kit contains all necessary materials and supplies to withdraw and preserve blood samples. Includes two 10 ml Vacutainer tubes containing 20 mg Sodium Fluoride and 10 mg EDTA, instructions for use, all necessary forms, seals and certificates to establish chain-of-possession for evidentiary proceedings.

4991 - This post Mortem Blood Alcohol Kit is specially designed for post mortem use. Kit includes two 10 ml Vacutainer tubes containing 150 mg Sodium Fluoride, single 10cc syringe and a 3 7/8", 16 guage needle. Also includes all necessary forms and seals to establish chain-of-possession for evidentiary proceedings.

4000 - This blood and urine combo kit is used for collecting and storing whole blood and urine. Kit contains all necessary materials and supplies to collect and preserve blood and urine samples, includes two 10 ml Vacutainer tubes containing 20 mg Sodium Fluoride and 10 mg EDTA, 50 ml urine tube, instructions for use, all necessary forms, seals and certificates to establish chain-of-possession for evidentiary proceedings.

3020 - Urine kit is used for the collection and storage of urine for drugs-of-abuse testing. Includes one 90

ml widemouth jar with screw-on caps, one temperature strip, instructions for use and all necessary forms and seals to maintain chain-ofcustody.
